

END USER LICENSE AGREEMENT (EULA) SCOPE SYSTEMS SOFTWARE

This End-User License Agreement (“EULA”) is a legal agreement between you and Scope Systems Pty Ltd, ABN: 41 128 664 853 (“Scope Systems”), governing the usage of software programs: PLODTrack, EMMTrack and Scope Systems Custom Modules.

1. GRANT OF LICENSE. Scope Systems grants the Customer a nonexclusive and non-transferable license to use for internal business purposes the Software and the Documentation for which Customer has paid the required license fees. “Documentation” means written information (whether contained in user or technical manuals, training materials, specifications or otherwise) pertaining to the Software. This is a license, not a transfer of title, to the Software and Documentation, and Scope Systems retains ownership of all copies of the Software and Documentation and all Intellectual Property Rights of the Software.

The Customer specifically agrees:

- (a) not to transfer, assign or sublicense its license rights to any other person or entity;
- (b) not to modify, make error corrections, merge all and any part of the Software with other computer program(s), or adapt the Software to create derivative works based upon the Software, or permit third parties to do the same;
- (c) not to reverse engineer or decompile, decrypt, disassemble or otherwise reduce the Software to human-readable form, except to the extent otherwise expressly permitted under applicable law notwithstanding this restriction or except to the extent that Scope Systems is legally required to permit such specific activity pursuant to any applicable open source license;
- (d) not to rent, lease or use or permit the Software to be used to perform services for third parties, whether on a service bureau or time sharing basis or otherwise, without the express written authorization of Scope Systems; and
- (e) shall preserve the confidential nature of the proprietary and trade secret information by retaining and using the Software in confidence, and using reasonable care and protection to prevent the unauthorised use, copying, publication or dissemination of the Software and Scope Systems Confidential Information learned from Customer's use of the Software.

2. RIGHT OF AUDIT. The Supplier reserves the right to audit the Customer's compliance with these licence terms from time to time.

3. ADDITIONAL COPIES. The Customer has no license or right to make or use any additional copies of the software with the single exception of additional copies necessary for backup purposes only.

4. TERM AND TERMINATION. The Agreement and the license granted herein shall remain effective until terminated. The customer may terminate this Agreement and the license at any time. The Customer's rights under the Agreement will terminate immediately without notice from Scope Systems if the Customer fails to comply with any provision of the Agreement. Upon termination, Customer shall delete the Software from all media and return to Scope Systems all copies of Documentation in its possession or control.

5. DISCLAIMER OF WARRANTY. TO THE MAXIMUM EXTENT PERMITTED BY LAW, SCOPE SYSTEMS DISCLAIMS ANY AND ALL OTHER WARRANTIES, WHETHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, CONDITION OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, SATISFACTORY QUALITY, NON-INTERFERENCE, ACCURACY OF INFORMATIONAL CONTENT, OR ARISING FROM A COURSE OF DEALING, LAW, USAGE, OR TRADE PRACTICE, ARE HEREBY EXCLUDED TO THE EXTENT ALLOWED BY APPLICABLE LAW AND ARE EXPRESSLY DISCLAIMED BY SCOPE SYSTEMS.

6. LIABILITY. TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, IN NO EVENT SHALL SCOPE SYSTEMS BE LIABLE FOR ANY SPECIAL, INCIDENTAL, PUNITIVE, INDIRECT, OR CONSEQUENTIAL

DAMAGES WHATSOEVER (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFITS OR CONFIDENTIAL OR OTHER INFORMATION, FOR BUSINESS INTERRUPTION, FOR PERSONAL INJURY, FOR LOSS OF PRIVACY, FOR FAILURE TO MEET ANY DUTY INCLUDING OF GOOD FAITH OR OF REASONABLE CARE, FOR NEGLIGENCE, AND FOR ANY OTHER PECUNIARY OR OTHER LOSS WHATSOEVER) ARISING OUT OF OR IN ANY WAY RELATED TO THE USE OF OR INABILITY TO USE THE SOFTWARE, THE PROVISION OF OR FAILURE TO PROVIDE SUPPORT OR OTHER SERVICES, INFORMATION, SOFTWARE, AND RELATED CONTENT THROUGH THE SOFTWARE OR OTHERWISE ARISING OUT OF THE USE OF THE SOFTWARE, OR OTHERWISE UNDER OR IN CONNECTION WITH ANY PROVISION OF THIS EULA, EVEN IN THE EVENT OF THE FAULT, TORT (INCLUDING NEGLIGENCE), MISREPRESENTATION, STRICT LIABILITY, BREACH OF CONTRACT AND EVEN IF SCOPE SYSTEMS OR ANY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

7. NEW VERSIONS AND NEW RELEASES

7.1 No obligation to provide new Versions or Releases – Scope Systems may provide Customer with a new Version or new Release it may make together with such information as may be necessary to explain the nature of the improvements and/or corrections contained in the new Version/Release, provided that the new Version/Release complies with the Specifications.

7.2 Obligation to take new Releases or Versions - Customer must install a new Release or a new Version in order to obtain, or to continue obtaining, Support Services, unless Supplier agrees otherwise.
